



三、监督受托人的机构类型 Types of Trustees

- > 监督受托人机构类型 Types of Trustees
 - ■投资银行 Investment Bank
 - ■会计师事务所 Accounting Firm
 - ■律师事务所Law Firm
 - ■经济咨询公司 Consulting Firm
 - 个人(1)Individual
- ➤ 结构性措施 Structural Remedies
 - 会计师事务所、投资银行或经济咨询机构担任监督受托人 Accounting Firm\Investment Bank \Consulting Firm
 - 必要时受托人会聘请律师担任法律顾问 Lawyers as legal counsel if necessary
- ➤ 行为性措施 Behavioral Remedies
 - ■律师事务所 Law Firms
 - ■可聘请技术专家等专业人士担任顾问 Technical experts as consultants if necessary

五、受托人未适当履行职责的认定和处理 Affirming and Dealing with trustees if they fail to properly perform their duties


- ➤ 监管方式 Ways of Supervision
 - 审阅监督受托人报告 Reviewing the Reports of Trustees
 - 当面听取受托人汇报 Meeting and Discussing
 - 听取委托任何第三方意见 Hearing of Third Parties' Opinions
- > 受托人未适当履行职责的处理

How to deal with trustees if they fail to properly perform their duties

- ➤ 未来可能采取的监管方式Possible Ways of Supervision in the Future
 - 任命受托人后将该任命及相关委托协议对外披露,接受社会监督和意见反馈 Disclosure of Appointment and Mandate
 - 对确有证据表明受托人未适当履行职责时,撤销对受托人的批准并要求委托人重新推荐受托人人选 Revocation and Re-selection of Trustees
